Prompt:

Choose an issue that you are passionate about to research and explore deeply, understand causes and effects, and evaluate the current solutions to draw a conclusion about how the issue should be addressed.

Structure:		
1.	Your response will take the form of a "White Paper" which, according to the Purdue OWL, is "authoritative and informative in nature. Writers typically use this genre when they argue a specific position or propose a solution to a problem" ("White Paper").	
2.	You will need to help the reader understand your issue, problem, or policy alternatives and guide the reader regarding solving the problem or making a decision.	
3.	Paper should be 5-7 pages, double-spaced, using MLA format and citations	
4.	You will need a well-developed, interesting and engaging introduction that leads into a complex, sophisticated thesis statement that completely answers all parts of the prompt	
5.	You will need a well-developed, interesting and persuasive conclusion that leaves your reader	

Note: This paper is NOT a summary of your research. You must give your reader sufficient background in order to understand your issue **and then** you must **argue** for a specific solution, that is, according to research, the best.

Body Paragraphs

feeling inspired to help

- 1-2 paragraphs **Background** (brief introduction of issue including relevant background/terminology/things your reader may need to know before they can keep reading)
- 1-2 paragraphs Introduction to Problem (general introduction to subject of paper explain the actual issue. Causes? Effects? Why is this a problem? Who or what is affected?)
- 2-4 paragraphs **Proposed/Current Solutions and Evaluation** of EACH (introduction of how problem is currently being addressed AND opinion on what is or is not working)
 - Describe solutions separately and include how they help solve the problem, the benefits of solution, and potential drawbacks
- 1-2 paragraphs Future Direction / Long-Term Focus {thoughts regarding the overall future direction of the problem and solution}

• Your recommendation of one solution over others & the advantages it has over the rest – why does the research and YOU think this is the best way to address this problem?
